

## WIRED HOME SOLUTIONS

Yes! You can have your tech and wire it too. Start reducing RF & EMF exposure today:

- ☐ Use hard-wired phones instead of cell or cordless phones. VoIP or Landline.

- ☐ With Children, always use Airplane-Mode. Keep the phone/baby monitor away from baby's body, head & eyes.
- ☐ Put your internet TV devices, home sound systems, wireless printers on a swich. Cut power when not in use.

## HEALTHY DISTRICT SCHOOLS

We support preparing our children for the future and supporting their health & development by eliminating WiFi and utilizing wired Ethernet connections in schools.

WiFi is not proven safe having never been premarket tested for children's safety. Since long term health risk assessment was never done by the FDA, CDC, NCI or EPA, WiFi use in schools is wholly inapropriate. We must not experiment on our kids!

A growing amount of scientific research links this wireless radiation to serious health effects—such as memory and sleep problems, headaches, cancer, and damage to brain development. Pulsed radio waves from a WiFi router overhead in the classroom exposes our children to RF levels like that of a cell phone tower across the street.

Gradeschool aged children do not need computers or tablets in school. Scientific research suggest that screen time is also hazardous to brain development. Our middle and highschool age children can work on & with computers using a wired connection.
